EUFORES News

Market feedback on energy efficiency policies available

EUFORES has published the results of a Europe-wide survey on the implementation of national energy efficiency policies in the EU Member States. The survey looks into the implementation of the policies as they were set in the National Energy Efficiency Action Plans in 2007 and 2011. The survey has been executed by Upper-Austrian Energy Agency, Energy Cities, FEDARENE and eceee. The members of those networks and many other experts have provided valuable feedback on the implementation of energy efficiency policies in their home countries. The survey is part of the Energy Efficiency Watch project of which EUFORES is the coordinator.

National parliamentary workshops

EUFORES is currently planning several **workshops for national stakeholders** on the RES Directive, its implementation, good practices and recommendations how to meet the 2020 objectives. Those workshops will be held in the national parliaments of several EU Member States within this and next two years. The workshops are part of the Keep-on-track! project.

Past events

Parliamentary Dinner: Future design of renewable energy markets 4 December 2012, European Parliament, Brussels

At this event, the future of the support mechanisms for renewable energy sources and new market designs for electricity and heating & cooling were in the spotlight. Simon Müller from the International Energy Agency presented several scenarios on the renewable power growth forecast and the market situation for renewables. A moderated debate with Claude Turmes (MEP), Tom Howes (European Commission), Bugra Borasoy (EnBW) and Josche Muth (EREC) followed.

EUFORES Inter-Parliamentary Meeting (IPM12)

EUFORES 12th Inter-Parliamentary Meeting took place on Friday, 23rd of November and Saturday, 24th of November in the Hellenic Parliament in Athens. This meeting of the most active parliamentarians in Europe in the field of renewable energy and energy efficiency was also attended by officials of national governments, the European Commission, experts and selected representatives from industry, the scientific sector and NGOs. The one-and-a-half-day conference was accompanied by a welcome reception, a gala dinner in the Dionysos Restaurant, with a breathtaking view of the Acropolis, and a lunch at the seaside. The first conference day focused on renewable energy related topics such as the renewable energy situation in Greece and in Europe, financing renewable energy projects and branding renewables. The second conference day presented energy efficiency as the main strategy as it is the way to tackle our current challenges such as climate protection, energy security, air quality and related health problems, economy growth and job creation.

Workshop: Implementation of the energy efficiency policies: market feedback



28 November 2012, European Parliament, Brussels

Christiane Egger (O.Ö.Energiesparverband) and Ralf Schüle (Wuppertal Institute) presented the **results of the survey** on implementation of national energy efficiency policies in the EU27 and the screening of National Energy Efficiency Plans (NEEAPs) to the members of the Coalition for Energy Savings. The survey results have proved that the NEEAPs have improved in their quality. The analysis has shown that sectoral policy packages (e.g. appliances, buildings) in some Member States are to a large extent based on EU legislation and many Member States have not yet adopted a long term energy efficiency strategy. Transport is the weakest sector of all. The experts who participated in the survey saw energy audits as the most effective instrument, followed by certification schemes and energy efficiency funds.

Irish Presidency Briefings

10 October & 27 November 2012, European Parliament, Brussels

Before Ireland has taken over the presidency in the Council of the EU on 1 January 2013, EUFORES had organised two meetings with Irish Energy Attaché Michael Goodwin. The first meeting focused on priorities of the upcoming Irish presidency in renewable energy and the second one in energy efficiency. Several Members of the European Parliament attended the meetings and engaged in the discussion with Michael Goodwin who introduced the Council agenda for the first half year of 2013.

Profiles of EUFORES Board of Presidents and Extended Board

Bas Eickhout

Bas Eickhout was elected to the European Parliament in the 2009 elections for the Green Left. This Dutch politician is a Member of the Committee of the Environment, Public Health and Food Satefy as well as a member of the Delegation for relations with the United States. Bas Eickhout worked previously as a scientific climate researcher at Planbureau voor de Leefomgeving in the Netherlands where he worked on the IPCC Fourth Assessment Report.



Vicky Ford

Vicky Ford was elected a Member of the European Parliament in the 2009 elections for the Conservative Party. She is a member of the Committee on Industry, Research and Energy and a member of the Delegation to the ACP-EU Joint Parliamentary Assembly. Vicky Ford worked as shadow rapporteur for the European Conservatives and Reformists Group on energy efficiency legislation and research funding matters.





Bernd Lange

Bernd Lange was elected member of the European Parliament in 2009 for Social Democratic Party of Germany. He joined the Group of the Progressive Alliance of Socialists & Democrats in the European Parliament. He had previously worked as Member of the European Parliament from 1994 to 2004. Bernd Lange is a member of the Committee on International Trade and a substitute of the Committee on Industry, Research and Energy. Since June 2010 he is the European Parliament's rapporteur for European industrial policy.

What is EUFORES?

<u>EUFORES</u> is a European cross-party parliamentary network with Members from all major political groups in the European Parliament as well as in the national EU Member States Parliaments. It is non-profit organization founded in 1995 by Members of Parliament and other key actors.

Its core objective is to promote renewable energy sources and energy efficiency and to facilitate discussion between the parliamentarians, experts, relevant decision makers and stakeholders. It organizes numerous events for parliamentarians each year, most of which take place in the European Parliament. The most important event is an annual Inter-Parliamentary Meeting on Renewable Energy and Energy Efficiency which is a meeting of parliamentarians from 27 EU Member States. This conference takes place in a different national parliament on a rotation basis.
